Professor Mathew Tsamenyi, China Europe International Business School (CEIBS) Africa, Ghana



Mathew Tsamenyi is Professor of Management Practice in Accounting at CEIBS and the Executive Director, CEIBS Africa. Before joining CEIBS Mathew was Professor of Accounting at the Birmingham Business School, UK. Mathew has also taught at various institutions including the University of Sheffield, UK, and the City University of Hong Kong. He was the former and founder President of the African Accounting and Finance Association and former Chair of the British Accounting and Finance Association, Special Interest Group on Emerging Economies. He was the co-founding editor of the Journal of Accounting in Emerging Economies and currently serves as a consulting editor for the journal. Mathew is the co-author of "Handbook of Accounting and Development" published by Edward Elgar Publishers, UK.

Mathew has extensive research and consulting experience in financial analysis and performance management. These experiences have been homed in related work in different socio-economic environments e.g. Ghana, Rwanda, Nigeria, Indonesia, Brazil, Mauritius, Kenya, and United Kingdom. He has consulted widely for various organizations including the African Development Bank looking at governance in Africa, Ashanti Goldfields Corporation in Ghana, the United Nations Conference on Trade and Development (UNCTAD), the Netherlands Organization for International Cooperation in Higher Education (Nuffic), and the Central Bank of Rwanda.

Mathew serves on the editorial board of Accounting, Auditing and Accountability Journal and the Journal of Accounting and Organizational Change.

Professor Marc Goergen, Professor of Finance, IE Business School, IE University, Spain



Marc Goergen holds a DPhil in Economics from Oxford University, a master's degree from Solvay Business School and a bachelor's degree in economics from the Université Libre de Bruxelles. He has been a full professor of finance at IE Business School, IE University, in Madrid since September 2018. Previous appointments include UMIST and the Universities of Cardiff, Manchester, Reading and Sheffield. Marc is an Honorary Professor at Cardiff Business School, a Research Member of the European Corporate Governance Institute (ECGI) and a board member of the International Corporate Governance Society (ICGS). He is an associate editor of British Accounting Review, British Journal of Management, European Financial

Management, and European Journal of Finance. He is past joint editor-in-chief of Annals of Corporate Governance and past associate editor of Journal of Banking & Finance and Journal of Corporate Finance. He is also a former member of the Corporate Governance Committee of the Institute of Chartered Accountants in England and Wales (ICAEW).

Marc's research interests are corporate finance and corporate governance. His research papers have appeared in top academic journals, such as Entrepreneurship Theory and Practice, the Journal of Finance, the Journal of Financial Intermediation, and the Journal of Corporate Finance. The quality of his research is further evidenced by several awards, including best paper awards from the European Corporate Governance Institute and the European Financial Management Association. Marc has also authored or co-authored three monographs on corporate governance and contributed chapters to numerous edited books. The second version of his successful textbook on corporate governance, entitled "Corporate Governance: A Global Perspective", was published by Cengage in 2018.

Mrs Mildred Chiri, Former Auditor-General of Zimbabwe, Zimbabwe.



Mrs Mildred Chiri is a former Auditor-General of Zimbabwe, a position she held from 2004 until 2023. In this role, she had oversight responsibilities for the audits of ministries, fund accounts, parastatals, and local authorities in Zimbabwe. Mrs Chiri spent 40 years in the Office of the Auditor-General starting as Audit Assistant in 1983 and rising through the ranks to the position of Auditor-General. Prior to taking up this role, she was the Deputy Auditor-General in charge of the Parastatals Section for which her responsibilities included monitoring the quality of audits conducted by private auditing firms on parastatals and local authorities in Zimbabwe to ensure compliance with applicable laws and regulations.

Mrs Chiri currently sits on the boards of the Insurance and Pensions Commission, First Transfer Secretaries (Pvt) Ltd and the United Methodist Healthcare Trust. She also served as board member of other organisations, including the INTOSAI Development Initiative (a body that assists Supreme Audit Institutions across the world), the African Organisation of Supreme Audit Institutions (AFROSAI) (and as the vice president of AFROSAI for English Speaking countries), the Interim Oversight Board on the professionalization of Public Sector Accounting and Auditing in Africa, and the Public Accountants and Auditors Board (PAAB). She served as the patron for the Institute of Internal Auditors in Zimbabwe and a member of the board that developed the National Code on Corporate Governance in Zimbabwe. Mrs Chiri is a recipient of the Chartered Secretary award 2010 and the Women's Top Leaders Excellence Award 2016.

Mrs Chiri holds a Bachelor of Accountancy degree from the University of Zimbabwe and MBA from National University of Science and Technology, Zimbabwe. She is a qualified Public Sector Professional Accountant, fellow of the ACCA, and fellow of the Chartered Governance and Accountancy Institute in Zimbabwe.

Dr Ndidi Nnoli-Edozien Member of the International Sustainability Standards Board (ISSB), London.



Dr Ndidi Nnoli-Edozien is a full-time member of the International Sustainability Standards Board (ISSB) since July 2022. She has a PhD in social ethics, cultural adaptation, sustainability and governance from the Johann Wolfgang Goethe University in Germany and a Bachelor's degree from the London School of Economics and Political Science, UK.

Her career has been focused on building connections between business and sustainable development, working across multinational and indigenous companies, public institutions, and civil society organisations—in Africa and Europe—to initiate sustainable development initiatives. She served as the inaugural Group

Chief Sustainability and Governance Officer of Dangote Industries Limited—one of Africa's largest manufacturing businesses—from 2017 to 2020. In this role, she was responsible for developing the company's sustainability culture, strategy, and reporting across 14 countries. Dr Nnoli-Edozien has also served on several

boards, committees and initiatives focused on corporate culture, impact investing, sustainability reporting and governance.

Visa Application

Zimbabwe issues a Conference Visa for foreigners travelling for purposes of attending a conference, seminar, or workshop. The visa may be issued for a period of 30 days and is non-renewable. The application requirements are:

- Passport photo
- Passport scan of biodata page
- Proof of residence of Host country (where applicable)
- Previous Zimbabwean Visa (if you have travelled to Zimbabwe before)
- Letter of Invitation

The application process for a Zimbabwean visa may vary depending on your country of citizenship. However, in general, most visitors to Zimbabwe will receive a visa at the point of entry into the country (please see https://www.evisa.gov.zw/home for information). It is important to check the specific visa requirements for your country before you travel to Zimbabwe.
